Terms and Conditions:

The below mentioned are the terms and conditions governing Customer’s access to and purchase of goods from Woolworths Wholesale (India) Private Limited (hereinafter referred to as “Woolworths”)

1. Woolworths sell goods to the customers on the condition that they are purchasing goods for resale, commercial, business or industrial use only. The customer agrees not to purchase goods for personal consumption.
2. Woolworths sell goods only to the customers having a valid registration with Woolworths. Customer agrees to fill in the registration form with proper details and submit necessary proof of VAT/other registration certificates advised by Woolworths from time to time.
3. Woolworths reserve right to prescribe minimum purchase quantities and/or purchase value for each invoice. Woolworths also reserves right to place maximum limit on the products purchased by the customers. These minimum/ maximum quantities are subject to modification from time to time by Woolworths.
4. Terms of sale will be ex-warehouse and Woolworths will not be responsible for transportation, insurance, and delivery of goods.
5. The customer is required to pay for the goods before supply. Till the time, cheque is cleared into Woolworths Account, property and ownership of goods will not pass to the customer and will remain with Woolworths. Untill property and ownership of goods passes to the customer, the customer shall hold such goods on trust as fiduciary bailee for Woolworths, and store them in a manner to enable them to be identified and cross-referenced to particular invoices. In such case, the customer authorizes Woolworths or its agent to enter into its premises, using such force as is necessary, to remove any goods which are the property of Woolworths, and the customer agrees to indemnify Woolworths against all costs and claims in respect of its exercise of its rights under clause mentioned above.
6. The customer payment for goods constitutes confirmation of receipt of goods without any defects.
7. Customers will be entitled to warranty as described in warranty cards attached to goods purchased. For any defect in the goods, customers are required to directly contact the manufacturer of the goods. Woolworths will not be liable to take return of any unsold or defective goods.
8. Price of goods are liable to change without notice.
9. You agree to notify Woolworths of any changes which affect the legal entity, structure or management control of your business.
10. This Agreement is personal to you and you have no right to transfer or assign this Agreement or any rights given by this Agreement or any part of that right without the prior written consent of Woolworths which may or may not be provided by Woolworths.
11. Transaction between Woolworths and the customer will be on principal to principal basis.
12. Unless provision is made in writing, you agree that you shall not represent to any third party that you are in any way acting for Woolworths and Woolworths will not be bound by any contacts that you make with any third party for the sale of goods.
13. Woolworths reserve right to change these terms of trade from time to time without notice to you.
14. If Woolworths fails to enforce any terms of trade at any time, Woolworths have not waived those rights.
15. In case of any dispute between the parties, Courts in Mumbai shall have exclusive jurisdiction over the matters.

If any provision of these terms of trade is held to be invalid or unenforceable for any reason, the remaining terms and conditions shall remain in full force and effect and the parties shall adjust their respective rights and obligations in accordance with the spirit and intent of the parties as shown by these terms of trade.

LETTER FROM CUSTOMER FOR CREDIT REQUEST ON THE LETTER HEAD

Dear Sir,

Sub: Request for Extension of Credit Period of 7 calendar days

I/we am/are purchasing goods from Woolworths on cash and carry basis. I/you request you to allow me/us 7 days credit period for payment of goods purchased by me/us.

I/we agree and confirm that -

- Woolworths have exclusive right to set up credit limit for my/our account which can be increased or decreased by Woolworths at its own discretion. In case credit limit is exhausted before the credit period, if any, provided by Woolworths, Woolworths shall have right to refuse further supply to me/us until the payment is made.
- I/we will provide bank guarantee in the format provided by Woolworths, of such amount as may be directed by Woolworths from time to time.

OR

- I/we will deposit Post dated cheque of such amount as may be directed by Woolworths from time to time.
- Till the time payment made to Woolworths, property and ownership of goods will not pass to me/us and will remain with Woolworths. I/we will hold such goods on trust as fiduciary bailee for Woolworths, and store them in a manner to enable them to be identified and cross-referenced to particular invoices. I/we authorize/s Woolworths or its agent to enter into its premises, using such force as is necessary, to remove any goods which are the property of Woolworths, and I/we customer agree/s to indemnify Woolworths against all costs and claims in respect of its exercise of its rights under clause mentioned above.
- I/we will not create any lien or mortgage the goods till the payment is made to Woolworths.
- I/we will indemnify and to reimburse to Woolworths all or any expenses that Woolworths may be reasonably incurred in recovering or attempting to recover payment from me/us of the amounts, which may from time to time overdue. I/we agree/s that Woolworths may at any time or from time to time without assigning any reason therefore, refuse to extend credit to me/us.
- Unless Woolworths has agreed to extend credit to me/us, I/we will pay for the goods before supply and I/we will not be considered to have paid until the payment has fully cleared through the banking system into Woolworths Account. In case Woolworths has agreed to extend credit period, I/we will make payment within agreed credit time period. In case I/we fail/s to make payment within agreed time period, I/we will be liable to pay interest @ 18% on payment due.
- Unless otherwise notified in writing, I/we am/are authorized to sell the goods in the ordinary course, but I/we will keep the proceeds of any goods sold in a separate account in trust for Woolworths.
- Notwithstanding anything mentioned above, all payments shall immediately become due to Woolworths, if I/we become insolvent, commit any act of bankruptcy, if receiver, liquidator or any other person is appointed over any of my/our assets or undertaking or if I/we make or attempt to make an arrangement or composition with creditors.
